#### INVITATION TO TENDER

The High Commission of India, Nairobi for and on behalf of the President of India, invites Lump-sum Fixed Price Tender for Supply and installation of a Generator Set of 30 KVA capacity to High Commission of India, Nairobi.

The Bid shall be submitted in a large sealed envelope duly mentioning "Supply and installation of a Generator Set of 30 KVA capacity to High Commission of India, Nairobi." with two sealed envelopes containing Technical Bid and Financial Bid.

The Bid shall be submitted before 3.00 p.m. on or before 21st June, 2021 at the High Commission of India, Nairobi

Any Bid received after this date and time will not be considered and will not be opened.

High Commission of India, Nairobi, however, will always have the right to accept or reject any pre-approved sub-Contractor even after formal award of Contract and/or commencement of work with or without cause.

Eligibility Criteria: The Tenderer should have valid permit / registration from a competent local authority for supply of such electrical equipment to the residences/Chancery of any country. The Tenderer should have satisfactorily completed (i) one similar supply and installation of 80% value of cost estimates or (ii) two similar supplies and installations of 60% value of cost estimates during last 02 years. Bidder should demonstrate and explain their technical, professional and practical experience of having supplied and installed similar devices to public/private organizations including Diplomatic/ International organizations in Nairobi.

Lump Sum Fixed Price Tender- This is a LUMPSUM FIXED PRICE TENDER with Extent of Supply as shown on scope of works. The Tenderer shall examine the scope of work and other Documents and all Addenda (if any) before submitting his Tender and shall become fully informed as to the extent, quality, type and character of operations involved in the supply. The Tenderer shall visit and acquaint himself with the Site of the installation. The tenderer shall take entire

responsibility in the interpretation of this report and of the site conditions. No consideration or compensation will be given for any alleged misunderstanding of the nature of the work to be executed.

### Tender and Schedule of Quantities-

(i) Schedule of Quantities should be enclosed by Bidders. Bidders are requested to identify and quote the rates of individual items. Items required for completion of the supply work may be added in the Schedule of Quantities with full nomenclature of the item. Bidders shall satisfy themselves of the quantities quoted in the Schedule of Quantities. These quantities shall be taken as guidance to assess the approximate quantum of work involved in the project. The Contractor prior to the submission of the tender, may add to items, quantities to the items in Schedule of Quantities as per the scope of the work, and site visit. It shall be the responsibility of the bidder to satisfy himself of the completeness of the documents for the scope of work and his own assessment of the supply work after site visit and as per the tentative scope of work mentioned in tender document. No extra cost shall be entertained and payable if any additional information or detail is provided later for carrying out the works as specified in the tender documents.

The supply and installation shall be completed within Seven (07) days from the date of issue of Purchase Order. Liquidated damages shall be levied on supplier for delay in supply and installation if it is ascertained that suplier is responsible for delay. The rate of liquidated damages shall be calculated @ 0.5% of contract amount per week limited to maximum 10% of contract amount.

The tenderer shall guarantee among other things, the following: - a. Quality, strength and performance of the equipment.

Retention Money: 5% of contract amount for 12 months i.e., till the Defect Liability Period is over.

Opening of Bids- Bids shall be opened at 3.30 pm on the last day of submission of the tender at the High Commission of India. In case of extension of last date of bid submission, the bid opening date will be changed accordingly.

Conditional Acceptance of the Tender- The acceptance of the Tender shall be conditional and not finally binding upon the Employer. The Employer may withdraw the acceptance of the Tender without any notice or other formality and may enter into a new Agreement for the execution of the Works or any part of it.

**Disqualification of Tender-** Tender may be disqualified for any reason including, but not limited to the following:

- a) If tenderer sets forth any conditions which are unacceptable to the Employer.
- b) If any tender is submitted under a name other than the name of the individual firm, partnership or corporation that was issued the Tender Document.
- c) If there is evidence of collusion between Bidders.
- d) If Tenderer sets forth any offer to conditionally discount, reduce or modify its tender.
- e) If Bid price is disclosed before opening of Financial Bid.

# Compliance with Laws and Regulations and Pricing of Schedule of Quantities:

The attention of Bidders is drawn as to compliance with laws and regulations concerning safety and health, labour regulations, social insurance, labour taxes, tax deduction, import restrictions duties and levies, company's tax, input tax and output tax (VAT) etc. All rates and sum inserted against items of works and in Form of Tender shall be exclusive of Value Added Tax.

16. All payments (**Excluding retention money**) shall be released after successfully completion of entire supply and installation.

## Scope of work

Supply and installation of a 30KVA Diesel Generator Set at High Commission of India, Nairobi with following indicative specifications.

- Prime Rated SILENT DG Set comprising of Cummins make engine X2.7TAA G3 Coupled to 30 KVA, 3P 415V STAMFORD make alternator mounted on a common base frame or equivalent or better brand specifications.

#### **INCLUDING**

- (a) First fill of lube oil.
- (b) Batteries & Leads.
- (c) Residential Silencer.
- (d) Fuel Tank (80-100 litre).
- (e) 63A Auto Changeover Panel double contactor based.
- (f) Auto / Manual : selector switch and remote operation of genset in manual mode.
- (g) 4pole contactor with MCCB for the power incomers.
- (h) Voltage, amperes and frequency meters (digital). Single phase preventer relay, Control MCB, 24v Battery charger, Timer and Relay, indicating lamp, switch, push button etc. required for smooth operation of Gen set.
- (i) Supply and installation of required cabling/ wiring to connect all our offices (01<sup>st</sup> Floor, 02<sup>nd</sup> Floor and 04<sup>th</sup> Floor). (Site survey can be done during office hours with prior permission. Mr. Rajesh can be contacted on mobile no. 0731900071)

The generator will operate as an emergency back-up in case of electricity outage and will supply the Mission with emergency power for all electrical and electronic devices including, but not limited to lighting, IT equipment, EPABX, Internet routers and switches. The generator will have to be installed with a switch key which should automatically operate the generator upon power outage and turn it off once the power supply is back to normal during working hours.

**Warranty**: The supplier will spelt out the warranty period and life expectancy for the items supplied under this contract which will include free service and maintenance as per requirement and response to emergency call to ensure smooth operation of the generator set.

Annual Maintenance Contract: -The bidder shall also provide Annual Maintenance contract costbeyond warranty period. However, the same will be executed at discretion of the High Commission. The AMC cost will also be taken into consideration for evaluating the tender. Draft AMC with terms and conditions may be provided.
