INVITATION TO TENDER

The High Commission of India, Nairobi for and on behalf of the President of India, invites Lump-sum Fixed Price Tender for **Renovation of a multipurpose court in High Commission of India Residential Complex at Wangapala Road, Highridge, Parklands, Nairobi**

The Bid shall be submitted in a large sealed envelope duly mentioning **“Renovation of a multipurpose court in High Commission of India Residential Complex at Wangapala Road, Highridge, Parklands, Nairobi”** with two sealed envelopes containing Technical Bid and Financial Bid.

The Bid shall be submitted before 3.00 p.m. on or before 10th June, 2021 at the High Commission of India, Nairobi

Any Bid received after this date and time will not be considered and will not be opened.

High Commission of India, Nairobi, however, will always have the right to accept or reject any pre-approved sub-Contractor even after formal award of Contract and/or commencement of work with or without cause.

Eligibility Criteria: The Tenderer should have valid permit / registration from a competent local authority for carrying out renovation works in the residences/Chancery of any country. The Tenderer should have satisfactorily completed **(i) one similar work of 80% value of cost estimates or (ii) two similar works of 60% value of cost estimates.**

Lump Sum Fixed Price Tender- This is a LUMPSUM FIXED PRICE TENDER with Extent of Work as shown on scope of works. The Tenderer shall examine the scope of work and other Documents and all Addenda (if any) before submitting his Tender and shall become fully informed as to the extent, quality, type and character of operations involved in the Works. The Tenderer shall visit and acquaint himself with the Site of the Works. The tenderer shall take entire responsibility in the interpretation of this report and of the site conditions. No consideration or compensation will be given for any alleged misunderstanding of the nature of the work to be executed.

Tender and Schedule of Quantities-

(i) Schedule of Quantities should be enclosed by Bidders. Bidders are requested to identify and quote the rates of individual items. Items required for completion of the work may be added in the Schedule of Quantities with full nomenclature of the item. Bidders shall satisfy themselves of the quantities quoted in the Schedule of Quantities. These quantities shall be taken as guidance to assess the approximate quantum of work involved in the project. The Contractor prior to the submission of the tender, may add to items, quantities to the items in Schedule of Quantities as per the scope of the work, and site visit. It shall be the responsibility of the bidder to satisfy himself of the completeness of the documents for the scope of work and his own assessment of the work after site visit and as per the tentative scope of work mentioned in tender document. No extra cost shall be entertained and payable if any additional information or detail is provided later for carrying out the works as specified in the tender documents.

Commencement of the works shall be effected within Seven (07) days from the date of issue of Acceptance letter or handing over the site, whichever is later.

The Period of Completion for the whole of the work is **30 days** calculated from the Seven days from the date of issue of Acceptance Letter to Letter of Intent or handing over the Site, whichever is later. Liquidated damages shall be levied on Contractor for delay in completion if it is ascertained that contractor is responsible for delay. The rate of liquidated damages shall be calculated @ 0.5% of contract amount per week limited to maximum 10% of contract amount.

The tenderer shall guarantee among other things, the following: - a. Quality, strength and performance of the materials used; b. Stability of the construction ; c. Satisfactory completion of work.

Defect Liability Period: Defects Liability period will be 24 months from completion of project.

Retention Money: 5% of contract amount for **24 months** i.e., till the Defect Liability Period is over.

Opening of Bids- Bids shall be opened at **3.30 pm on the last day of submission of the tender** at the High Commission of India. In case of extension of last date of bid submission, the bid opening date will be changed accordingly.

Conditional Acceptance of the Tender- The acceptance of the Tender shall be conditional and not finally binding upon the Employer. The Employer may withdraw the acceptance of the Tender without any notice or other formality and may enter into a new Agreement for the execution of the Works or any part of it.

Disqualification of Tender- Tender may be disqualified for any reason including, but not limited to the following:

- a) If tenderer sets forth any conditions which are unacceptable to the Employer.
- b) If any tender is submitted under a name other than the name of the individual firm, partnership or corporation that was issued the Tender Document.
- c) If there is evidence of collusion between Bidders.
- d) If Tenderer sets forth any offer to conditionally discount, reduce or modify its tender.
- e) If Bid price is disclosed before opening of Financial Bid.

Compliance with Laws and Regulations and Pricing of Schedule of Quantities:

*The attention of Bidders is drawn as to compliance with laws and regulations concerning safety and health, labour regulations, social insurance, labour taxes, tax deduction, import restrictions duties and levies, company's tax, input tax and output tax (VAT) etc. **All rates and sum inserted against items of works and in Form of Tender shall be exclusive of Value Added Tax.***

16. All payments (excluding retention money) shall be released after successfully completion of entire work.

Scope of work

Area : 25 m X 18 m = 450 sq. meter (Approx.)

(a) Leveling and resurfacing of the court with concrete/ screed (with wire mesh) of minimum 50 mm thickness including the provision of expansion joints.

(b) Thick standard rubberised paint (olive green/ olympic blue) coating on the renewed surface.

(c) Straightening the existing fencing poles.

(d) Extending the height of the existing poles upto 05 meter height and also providing horizontal strengthening members to increase the stability of the poles. Painting of entire framework (including existing and extended) post surface preparation applying anti rust coat.

(e) Replacing the existing chain link fence with new one having same specification covering increased height upto 05 meter.

(f) Supply of portable Volley Ball net and poles.

(g) Requisite markings with suitable color coding on the floor, as per Volley Ball, Tennis Court and Basket ball courts' dimensions.

(h) Supply and installation of 06 nos. Solar powered LED lights of 150 Watt with auto cut-in and cut-out switch, remote control along with provision of battery storage (with 02 years of warranty). (N. B. : The lights can be added if required. Hence, price break per light installation should be given).

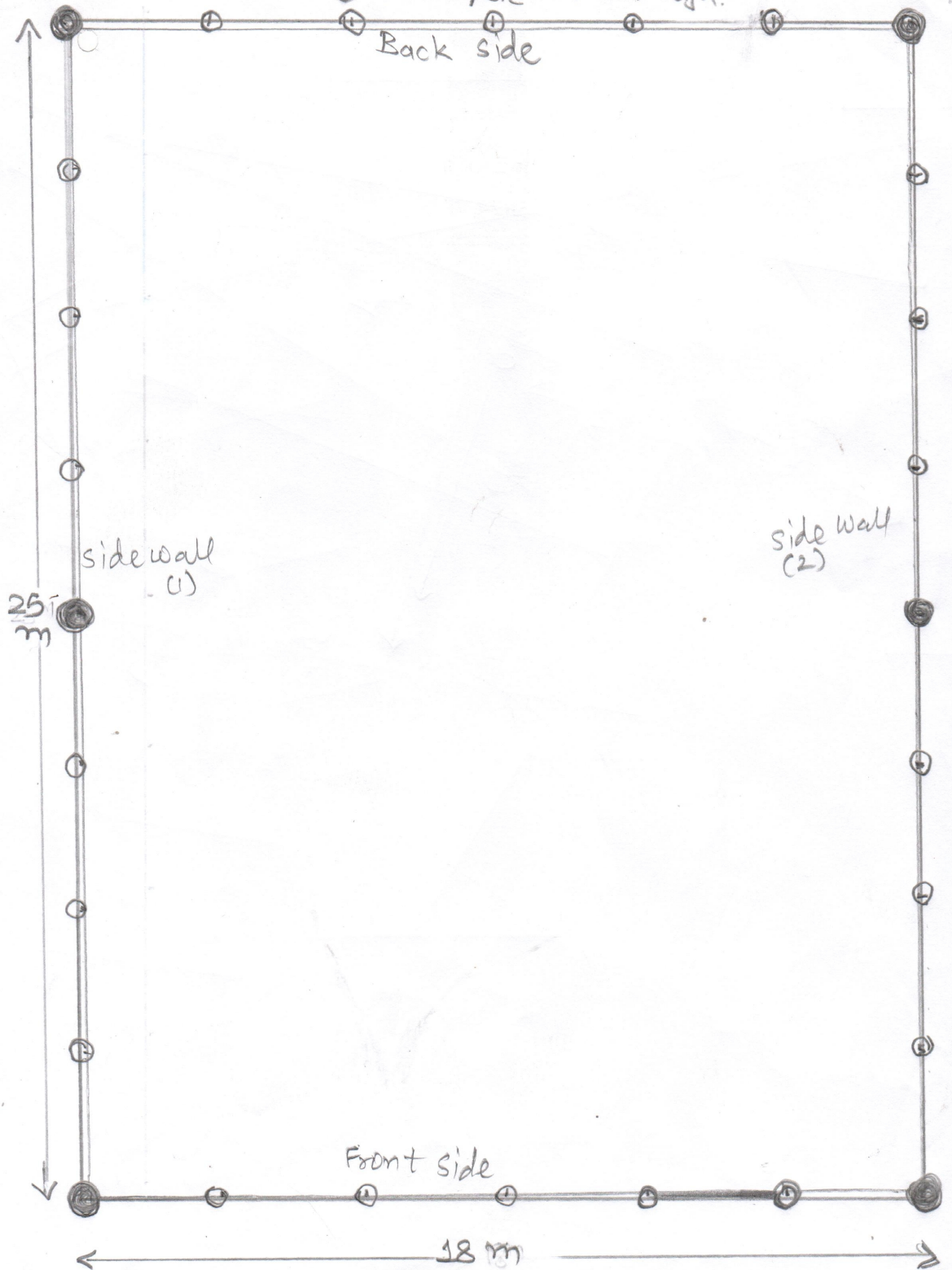
(i) Provision of openable spaces in the fence to facilitate movement of material in and out of the court.

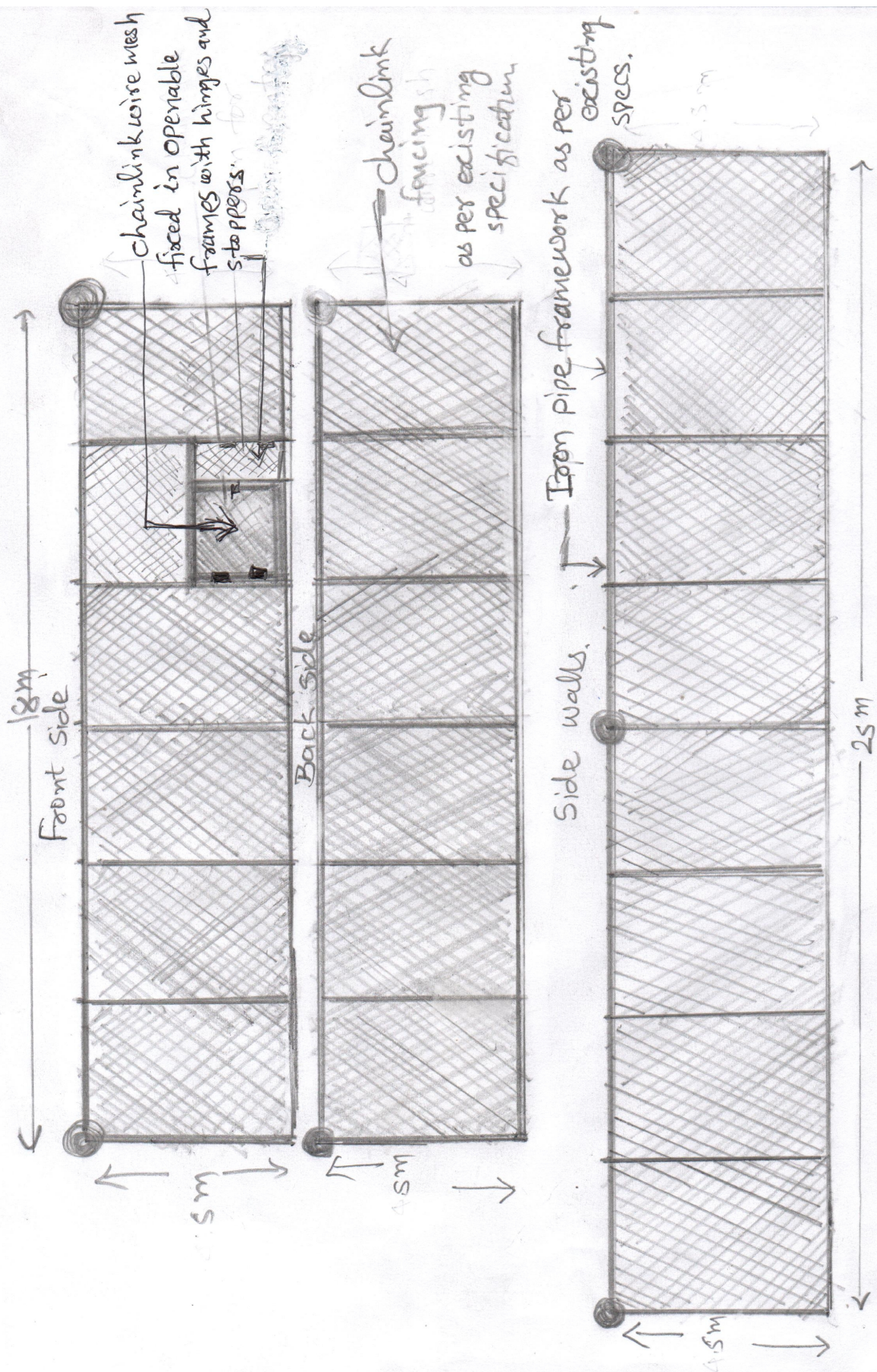
